Recommendation: Adopt Resolution No. 2025-14 adopting the BY25-27 biennial budget, making appropriations, and declaring tax increment.

Executive Summary: The NURA Budget Committee met on May 5, 2025 to review and deliberate on the proposed BY25-27 NURA Budget presented by the Administrator Worthey and Finance Director Strode. The Budget Committee approved the budget on May 5, 2025. A summary of the appropriations is included in this packet as Exhibit A.

Fiscal Impact: The BY25-27 Approved Biennial Budget equals \$2,376,237. Total appropriations equals \$2,376,237, with unappropriated ending fund balances totaling \$0. This is the third year the NURA expects to receive funding.

Strategic Assessment: This is a balanced budget and reflects the direction and priorities of the NURA and Newberg City Council to meet the needs of this community.

RESOLUTION No. 2025-14

A Resolution adopting the Newberg Urban Renewal Agency biennial budget for the BY25-27 fiscal year, making appropriations, and declaring tax increment.

Recitals:

- 1. The Newberg Urban Renewal Agency (NURA) Budget Committee approved the biennium BY25-27 budget on May 5, 2025.
- 2. The notice of this budget hearing and financial summary was published in the May 22, 2025 Newberg Graphic.
- 3. A public hearing on the approved budget was held on June 2, 2025.

The Newberg Urban Renewal Agency Resolves as Follows:

- 1. <u>Adopting the Budget</u>. The NURA Board of Commissioners hereby adopts the biennial budget for BY25-27 in the total amount of \$2,376,237 now on file at City Hall located at 414 E. First Street, Newberg, Oregon.
- 2. <u>Making Appropriations</u>. The amounts for the biennium beginning July 1, 2025, and for the purposes shown in Exhibit A are hereby appropriated.
- 3. <u>Declaring Tax Increment.</u> The NURA hereby resolves to certify to the county assessor for the NURA Plan Area a request for the maximum amount of revenue be raised by dividing the taxes under Section 1c, Article IX, of the Oregon Constitution and ORS Chapter 457.
- 5. <u>Certifying the Tax.</u> The Finance Director is authorized and directed to certify the division of taxes with the Yamhill County Assessor, providing copies to the Yamhill County Clerk.
