STAFF REPORTS & GENERAL INFORMATION:

1. Report from Newberg-Dundee Police Department

Sgt. Brian Hagan presented on police department activities, include a description of enforcement operations over the past year.

2. Report from City of Newberg Engineering

Senior Engineer Brett Musick gave and update on the status of steps intended to clear outstanding items on the Active Issues Log. These steps included working with the City Manager for inclusion of funds in the next budget cycle for obtaining traffic counts and other studies noted as needed for investigation of numerous items on the Active Issues Log. Senior Engineer Brett Musick also described development of a four-year Capital Improvement Program by the City Engineer that is in progress to align with the next budget cycle that begins July 2025.

The updated active issues log was discussed. Senior Engineer Brett Musick described the color coding that was added to indicate outstanding items that are under ODOT jurisdiction and outstanding items under City of Newberg jurisdiction that include some items dating back to 2019. The latest information on these outstanding items is highlighted under comments with the color-coding legend.

There was discussion regarding the need for assignment of resources, to address items in the active issues log that are noted as needing traffic counts or collection of other data to confirm issues and identify if various options are warranted. Senior Engineer Brett Musick described coordination underway with the City Engineer and City Manager for assignment of resources to work on clearing items on the active issues log.

The limited traffic decision issued for the intersection of Redwood Court at N Elliott Road to install signage or curb markings to delineate no parking areas within 20-feet of the marked crosswalk at this intersection was discussed.
